- 2015/0181: The Cottage, Top Row, Wreningham Proposed games and gym out building ancillary to existing dwelling. The Parish Council have no objection to the application.
- 2015/2634: Land East of Snowdrop House, Top Row new detached dwelling. The Parish Council
 believe that this is a personal dwelling and have no objection to the design, however wish to remind
 planners that the Parish Plan expressed a preference for smaller more affordable housing which
 this clearly contradicts.
- 2014/2137: Elm Tree Barn, Hethel Road Retention of a shed and green house. No views or comments on the application
- The Council agreed to include the CPRE standard clause in all applications unless agreed otherwise.

MH reported that he has been contacted by the developer at Church Road who expects to discuss with local residents the development, [including the design of the ten (of which three are designated as affordable) dwellings], at the beginning of July following the anticipated final approval by the planning instector for the South Norfolk plan.

- Crime Figures for January and February. Retained by the Clerk
- Better Broadband for Norfolk update. MH read an e-mail from NCC explaining that the village is having a new broadband cabinet installed near the school in preparation for the better broadband. The information is on the village website and updates will be posted as they become available.
- DC Webster. The Clerk read an e-mail update.
- MH met NCC's Gary Overland and Highways boundary surveyor to discuss highway boundaries
 and vision splays at the B1113 junction. Boundary definition is further required for the properties:
 The Birches, Mill Cottage and Travis Perkins site. The Travis Perkins fence alongside the B1113
 may be incorrectly sited as well as overhanging the highway boundary. NCC Highways to address
 directly with Travis Perkins. MH will report any developments to a future meeting. The Highways
 Boundary Surveyor noted that the adverse camber and approach speeds of vehicles into/round the
 corner indicated that the speed limit is not correct. This will be one of the factors considered by NCC
 in its Road Management Plan.
- MH has attended a meeting at Lotus and informed the meeting that Wreningham residents and families can apply for a 10% discount on Lotus events.
- MH attended a Passivhaus design standard conference at Hethel Engineering Centre and he explained the standards to the meeting. He will circulate the information outside the meeting.

683. Future Business
