652. Administrative Issues

• Electronic Archiving – MH had previously circulated information to Councillors explaining that he had approached Norfolk Records Office about receiving and retaining electronic archive media. The current solution is pdf documents, however the preferred format would be Open Format. The Council tablet computer does not use this format so for the interim it cannot be used as the Council standard. The long term solution is that when the computer is updated the replacement should support open format.

654. Village Maintenance

- <u>Drainage in Wymondham Road</u> MH reported back from a meeting held between TW, MH. (Notes attached to the signed minutes). There was lengthy discussion surrounding riparian ownership and possible ways forward.
- <u>SAM2 update</u> MH reported that the sign operating in the village. EB has asked to use it as monitor traffic on B1113. It was decided that due to the inherent risks, and the need to establish the sign in the village, this would not be supported for now.
- <u>B1113 Accidents</u> MH distributed notes from a meeting between MH and NCC Highways (attached to the signed minutes). MH received a telephone call from Gary Overland (Highways) informing him that safety works to the junction has been included in the NCC Traffic Management Programme. Mr Overland says this is because the case for considering action at this junction has been well made.
- Hethel Road update— Following a drainage issue between a resident and land owner, MH was asked to
 intervene and has spoken to both and helped them to agree a solution. The land owner has completed some
 work. NCC are aware of the issue. Also on Hethel Road, a farmer has filled in a ditch to allow his farm
 vehicles to access a field. A resident has asked him to clear the ditch but to date he has not complied.

655. Playing Field Update

- Reinstallation of playing field gate the gate has been re-installed by SD.
- Removal of Playing Field sign this will be removed by the contractor installing the play equipment (see next item).
- <u>Future Play Equipment</u> Two new items of play equipment will be installed in the next few weeks. Details will follow in due course.
- <u>Litter bin emptying risk assessment and dog bin request</u> The Clerk circulated a Risk Assessment requesting the Council purchase a dog bin to place at the roadside edge of the playing field to encourage people not to dispose of dog mess in the litter bin. Risk Assessment and purchase agreed. **Clerk to action.** Proposed: MH, seconded: JM

656. Finance

- The Clerk distributed an initial suggestion towards setting the precept for 2015/16. She noted that the deadline for submission of the precept is the end of January 2015 and the tax base and grant from SNC will not be confirmed until mid December. The Council discussed the suggestions and the Clerk will revise the document to bring to the next meeting for agreement. Gary Lake has quoted for grass cutting and requested a five year contract. This was agreed. Proposed: DW, seconded: MH.
