## Wreningham Parish Council - Minutes

# Meeting held on 15<sup>th</sup> October 2014 at 7.30pm held in the Margaret Preston Room, Wreningham Village Hall

#### 647. Planning

2014/1928: Sunnyside, 3 Glebe Close, Wreningham – retrospective change of use from paddock to garden.
MH noted that the deed of transfer from the land registry changes the covenant to the use of garden or
paddock. There are also comments on line, all of which are supportive of the application except one which
has a specific comment.

The meeting was closed at 7.35pm to allow members of the public to speak

The owner reported that the use was initially granted as a paddock, however according to DEFRA it is not of a size suitable for a horse and would be limited to a mule, llama or chickens. She is not aware of legislation against children playing in a paddock. In the past they have received notice from SNC that they were in breach of planning, but were found not to be. The owners thought they could lawfully set moveable objects on the paddock with no landscaping however two years later they got a second letter report of breach of planning. SNC enforcement then asked the owners to remedy the breech or submit a planning application. They removed the play equipment and applied for planning to replace the swings. As the paddock is Glebe Land, they have applied to the Diocese who have no issue with the change of use, Wreningham PCC have also agreed. The owner is aware that the objection is on the grounds of noise and reported that they have three children, one is at boarding school with the other two girls at home. They have never received notice either verbal or in writing of any low level noise complaints. They noted that the land is outside the planning area and have no plans to apply for building permission and there is a drainage system for The Glebe within the paddock which would also be jeopardised by the building of any property there.

Another resident agreed that you can hear the children playing, however turning the space into a garden would allow for planting of shrubs and trees which will dampen the noise. The field itself is unproductive as it stands, and if the owners start to plant it will attract wildlife which will be for the better of the village. They therefore believe that it should be approved.

A third neighbour commented that they have no problem with the noise of mowing the grass or children playing. They feel that application should be approved.

A fourth neighbour also has no problem. The feel that planting to attract bees and wildlife would be good and any tree roots would assist with removal of water from the drainage system.

A fifth resident has raised the issues with SNC. He has concerns with climbing frame at the back of the garden causing a privacy issue, and balls coming into his garden is causing a danger to his dogs.

A sixth neighbour who feels they have the most shared curtilage feels the application should be approved.

They suggest a condition that approval to erect any building other than that commensurate with use of garden would require permission from SNC. They felt that it was relevant that the use of the land as a garden would encourage landscaping and planting of trees and bushes which would benefit wildlife.
