708. Declaration of Interests.

709. Open Forum

Julian Wells (JW) – proposed development on Church Road. SNC discussed and formally agreed the outline plans ready for public consultation. There will be a display on Wednesday 19th August at The Bird in Hand which will be advertised by a flyer included in the Mardle and on the website. All comments made at that event will be included within the Statement of Community Involvement. The details for the plans and archaeological surveys were discussed. JW is planning to submit a planning application in September with the intention of beginning work in spring 2016 for a 12 month build project. He confirmed that the consultation will be a key part of the development and all constructive comments will be shared and considered. He agreed to provide information to residents about progress, the next stage will be site investigations followed by archaeological surveys (possibly in January 2016) before the build begins.

It was noted that the District Councillor has not attended any meetings since his election.
