## **Wreningham Parish Council - Minutes**

# Annual General Meeting held on 14<sup>th</sup> May 2013 at 7.00pm held in the Margaret Preston Room, Wreningham Village Hall

### **Present**

Cllrs Michael Hill (Chair), Elizabeth Brake, Jon Moon, the Clerk and 4 members of the public.

**525.** Election of Chair and Vice-Chair and signature of acceptance of office SD proposed MH for the position of Chair and this was seconded by JM. SD proposed EB for the role of Vice-Chair, and MH seconded this. MH and EB signed their declaration of acceptance of office.

**526. Apologies**: Cllr Sheldon Durant (Prior arrangements) and DC Webster. Gill Page has resigned her position on the Parish Council and the vacancy has been notified. If an election is not called, there will be option to co-opt at the next meeting.

### 528. Open Forum

Meeting closed at 7.10pm to allow members of the public to speak.

A resident wished to report that Plot 3, The Glebe has planning permission for a paddock but it is being used as a garden with climbing frames, etc. **Clerk to report to SNC.** Proposed: MH, seconded: EB

Trevor Wadlow reported that SNC have been addressing flooding issues. Part of a pipe at The Loke has collapsed, different size pipes are interconnecting and there are blocked drains on open dyke at the south end of Wymondham Road. The last open field at the top of Wymondham Road has a drain which is in urgent need of repair and SNC are addressing this issue. The old bung in the culvert under the road by the Loke has not been removed when it should have been, which has now been completed. NCC were instigating a full flood investigation however have now backtracked and will be awaiting further evidence before proceeding which is very frustrating. He asked the Parish Council to write to Richard Hendry to add their support. **Mr Wadlow to draft a letter for the Council to agree and send.** 

Mr Rob Jones, Head teacher of Wreningham Primary School, was not able to attend the Annual Parish Meeting so reported at this meeting. The building works have almost been completed. The space will be used to enable children to work in small groups outside the classroom. Ofsted have confirmed that they will not be inspecting until the summer term as the school are maintaining their good standards. Funding for the school has changed, and the budget is getting even tighter. 13 children will be entering in September which means that the school is not at capacity, but numbers are healthy. Links with the church were discussed and it was noted that the size of the church building can be limiting. MH reported that a resident has complained that the cones in the road outside do not need to be there out of school hours and are unsightly. Mr Jones said that the coloured cones outside the school are there to prevent parents parking in dangerous places however he will endeavour to remove the cones. The police cones outside on the corner by the Reading Room belong to Spratts and it was believed that these may be the ones in dispute.
