There were no comments from members of the **public**.

SNC CIIr Nigel Legg reported that SNC video conference meetings are usually open to the public. SNC is holding meetings with Broadland District Council to form joint policies and management and to make financial savings. He is lobbying for improved Pharmacy services in the local area particularly Wymondham, Hethersett and Mulbarton.

SNC CIIr Vivienne Clifford-Jackson reported about the business of SNC committees. Loans to Parish Councils were adopted under the Covid-19 Emergency legislation. Cllrs continue to pursue the issues of planning conditions not being met to our residents' satisfaction. SNC emphasise that planning decisions are a balance of economic, social and environmental factors.

The Chairman noted the proposed planning law changes which will mean local authorities will have less input. The Chairman has put a note out on this to councillors and Parish has received email from another local parish highlighting this change. Council agreed to put together a comment and the Chairman will put the link detailing this change online.

Discussion with SNC Councillors on recent Planning decision 2018/1583 on Land Adjacent to the Village Hall as detailed in point 6 below. Cllr Legg is in discussions with SNC Director of Planning. Cllr Francis highlighted the reservations and reluctance expressed by the Planning Committee Councillors.
