- 1 To consider apologies for absence SNC Cllr Vivienne Clifford-Jackson apologies received.
- 2 To receive declarations of interest none.
- 3 Open Forum, including reports from District & County Councillors
 - SNC Cllr Nigel Legg reported
 - o accommodation review amalgamating SNDC & Broadland DC offices is ongoing
 - proposed major roadworks on A11 Spooner Row to Thickthorn will go on until next year, expected increase in traffic
 - A further 65 applications received by SNC for village clusters scheme, display of proposal can be viewed at SNDC house.
 - Flooding works for South Norfolk, Long Stratton area allocated £1.25 million. Cllr expressed concern with planning situation as only 5 senior staff are making decisions and not enough public inclusion.
 - Health Scrutiny committee at County Council concerns raised at lack of GP resources and staff shortages, including cancer services.
 - New NCC Highways Engineer focussing on macro works with a budget of £1million
 - NCC Cllr Daniel Elmer introduced himself to the Parish. In post since May 2021.
 - circulates regular reports encouraged requests for specific areas the parish would like his reports to focus on
 - Discretionary spend budget of £10,000
 - SNC Cllr Nigel Legg encouraged Parish Councils to develop emergency plans for flooding, Shotesham Parish has developed one. Chair outlined understanding that unless very extreme flooding events County Council will not get involved. Highlighted ongoing drainage issue at the Wymondham Road Loke, this Council has commissioned a survey report and results received today to be on next meeting's agenda. NCC Cllr Daniel Elmer outlined no longer have resources and teams to look into smaller flooding issues and posts are not filled. The Chair requested County and District councils work together and engage with small communities.
 - Drainage report as outlined above member of public asked if available. Chair confirmed will look into publishing on website.

 - Swardeston site now proposing use of batteries proposers say will not affect surroundings, however noted site is over 50 acres.
 - NCC Cllr Daniel Elmer outlined £10,000 discretionary grants are available to parishes for small highway works.
 - Member of the public updated on County Broadband progress understanding that nearly at the 25% threshold to enable install, and a few weeks left before decision made.
 - Hedges around village a member of the public offered to cut back hedges preferred offer circulated by word of mouth instead of a general announcement.
