- 1 To consider apologies for absence Cllr K Morris, SNC Cllr Vivienne Clifford-Jackson apologies received.
- 2 To receive declarations of interest none.
- 3 Open Forum, including reports from District & County Councillors
  - SNC Cllr Nigel Legg reported
    - Consultants now appointed to find single office for SNDC staff accommodation review, one option identified is ex-Aviva building Horizon House at Broadlands business park.
    - Planning committee back up to 9 members from 15 November.
    - o Council offering grants to shopkeepers to improve business frontage, now available
    - The Bird in Hand proprietor considering installing electric charging point for customer use.
    - Humbleyard Practice have appointed 3 more nurse practitioners to help get through workload.
  - SNC Cllr Gerald reported if residents have overgrown road/path issues to make him aware so he can lobby Highways.
  - Chair raised query regarding current vacant Community police officer post. existing one left post and awaiting replacement. Cllr Nigel Legg confirmed current policing contacts as Local Beat Manager Stuart Barnard, Wymondham Policing Commander Inspector Burke.
  - Chair raised key points from NCC Daniel Elmer written report to the meeting
    - Adoption of overall strategy by the Norfolk Strategic Flooding alliance. They have set up a single phone number residents can call to report flooding on 0344 800 8013.
    - Free course offered by NCC to support budding business owners from 'Bedroom to Business.'
    - Chances Project helping Norfolk residents to get back into employment through new opportunities for support and training.
  - Footpaths Footpath Warden outlined recent completed repairs and monitoring outstanding issues with footpath off Silfield Road. These have been reported. Reports of Church Road footpath issues of mud and overgrowth. Chair to put in Mardle reminder on maintaining hedges responsibilities.

  - Member of the public raised subject of recent commissioned flood report and ongoing drain
    and flood issues at The Loke. Concern that recommendations in report will not address issue
    and will make situation worse. The Chair highlighted that all the pipes lie on private land and
    the various homeowners have been approached previously and not taken action. Cllr Legg to
    approach engineer of Norfolk Rivers Drainage Board for further advice on action needed.
    Agreement that next steps and Parish council involvement to be to write to the responsible
    householders and landowners with report copy and covering letter.
  - Cllr Jean Lambourne proposed village have another Christmas lights display and asked for council for contribution towards Christmas tree of £25 and this was agreed.
