- Open Forum, including reports from District & County Councillors
  - 1. Public in attendance
    - a) Fibre Broadband. Gigaclear is expressing an interest supply to the village. County Broadband has declared its plans for fibre provision to some residents, although their initial installation objectives seem to have slipped. Open Reach has been undertaking infrastructure work around the village. Chairman advised information about fibre provision will be posted when available.
    - b) Dog Waste Bin. Discussion on whether parish council might install a dog waste bin near Longs Wood, Wymondham Road. Council is in favour of purchasing a second bin. But placement is likely to be on Church Road at the end of the East/West public
    - c) Bus Shelter. Council were asked to consider a Bus shelter at the junction of Church Road and Hethel Road. This is primarily for children waiting for school buses. No decision was reached.
  - 2. No District or County Councillors in attendance.
- To approve the minutes of the last meeting agreed as a true record of proceedings.
  - 1. Chairman advised the playground report still needs to be reviewed by council. Cllr Tancred advised she would arrange a date for members to get together to review Action AT

- 2. Proposed pavement on B1113 Norwich Road NCC 'Parish Partnership' scheme for Local Highways – Cllr Jarvis has made contact with A Mayo, NCC Highways and the costs could exceed the maximum grant funding. There could be other grant funding which council may be eligible to apply for. Clerk to monitor **Action Clerk**
- 3. Chair to speak to Mr Moore to quote on the trees overhanging on the playing field. **Action MH**

4. Cllr Tancred informed council that the School has recently had a defibrillator installed on its premises. C Minns advised she is still trying to obtain funding for the electricity to enable a defibrillator funded by the parish council to be installed on All Saints Church. Clerk will also look into what grants are available to assist with costs. Chairman asked clerk to obtain new defibrillator pads and med kit from supplier.

Clerk advised members she was in receipt of email from G Lake regarding increase in costs for 2024. Due to increases in insurance and machinery parts he would be passing on an increase of £150.00 raising the seasonal cutting to £1065 for the maintenance of the Reading Room and Playing field. Council duly noted and will be discussing council budget and precept requirements for 2024/25 in the near future.

Chairman requested C Minns contact the clerk with regards to the one off payment of £250.00 towards churchyard maintenance. Also, the grant of £100 towards the village magazine needs to be applied for from the council.

It was proposed that Cllr Jarvis should become a signatory on the council bank account. Clerk to contact Barclays.

- 8 Village maintenance and highways
  - 1. Flooding on the B1113 north of the A47 by-pass bridge. Chairman had reported this on the NCC Highways portal but also spoken with contractors on the nearby construction site. The civil engineers have investigated and conclude that the evidence shows the run off was coming from a source other than their site. The surface water drainage system is overloaded and contractors will speak to NCC highways as this is causing them problems too. A balancing pool on the north side of the A47 bridge does not change level which is a sign that the drainage system is not working correctly. The problem will need to be addressed as they are on the site for the next four years.
  - 2. Village footpaths. The footpath by the church has been cut by residents of the village. Council passed on thanks to those who had carried this out. Clerk advised she had contacted NCC Highways engineer Adam Mayo to see if NCC would compensate the parish council if they took on the cutting of all village footpaths. Currently awaiting a response. NCC currently budget for two cuts a year. Clerk has also made contact with neighbouring councils to see whether they cut their own and if council could buy into their service. Mulbarton contract theirs out to Ribbonsdale. Ribbonsdale will quote if we supply them with a map of village footpaths. J Bunn who is located in Fundenhall will also quote should council wish to go down this route.
  - 3. Speed Awareness sign. New Bluetooth unit has been installed by Westcotec.
  - 4. <u>Playground Springer</u>. Clerk has obtained quotes but with installation this can cost up to £3,000. Cllr Glaves has spoken with a local firm who will install. Chairman asked Cllr Glaves to check they have the necessary insurance for installation. Clerk to order and deliver to Cllr Glaves.

## 9 The Farthings Project

A meeting was held on the 11<sup>th</sup> September 2023 to discuss setting up a working party which will include councillors. Attendees concerned about managing localised flooding near and on the site. To mitigate this there must be a water management plan. South Norfolk Council's Flooding Officer will have their say on the application and should look at the network as a whole. Council have always had their concerns with Hethel Road and have tried to get NCC Highways to look at this, by walking the site and to see at first hand the water levels in ditches particularly in the winter.

Chairman advised he has not received any further information from J Wells with reference to the site.

Concerns with the proposed self-build plots being left incomplete due to unforeseen circumstances.

It was proposed that council should call another meeting with J Wells before his planning application is submitted to South Norfolk Council.
